For sales of standards and standardization documents and for the services provided by the Bulgarian Institute for Standardization (BDS) (approved by Decision No 7/2006, amended and supplemented by Decisions 337/2014, 375/2015, 425/2016, 432/2016, 501/2018, 586/2021, 587/2021, 595/2021, 622/2022 and 637/2022 of BDS Governing Board)

For standards and standardization documents of over 400 pages, delivered online, the price shall amount to **513,30 BGN** plus **4,30 BGN** for every next 10 pages.

The price of standards purchased on disc or paper is calculated based on the price of the respective standard delivered online plus a 5% surcharge.

For standards implemented in one of the official CEN/CENELEC or ISO/IEC languages, and translated into Bulgarian, the price of the standard is determined on the basis of the number of pages when it is introduced for the first time as a Bulgarian standard, regardless of which language the edition is.

**2.** For purchasing a standard simultaneously in pdf format online and on paper, the price is 1,5 of the price of the relevant standard in pdf.

**3.** For draft standards and standardization documents, the price shall amount to 50% of the price according to item 1.

**4.** For foreign and international standards, the prices are determined by the relevant foreign and international standardization body.

**5.** The price of annual subscription to the electronic Catalogue of Bulgarian standards is **104,40 BGN**.

**6.** The price of annual subscription to BDS official bulletin is **156 BGN**.

**7.** The prices for provision of references are as follows:

**7.1.** The price for elaboration of references on the actuality of standards and standardization documents:

**7.1.1.** from 5 to 9 pcs. of standards and/or standardization documents – **18 BGN**.

**7.1.2.** from 10 to 30 pcs. of standards and/or standardization documents – **30 BGN**.

**7.1.3.** from 31 to 50 pcs. of standards and/or standardization documents – **60 BGN.**  
**7.1.4.** for every next 10 pcs. of standards and/or standardization documents – **15 BGN.**

**7.2.** The price of bibliographical reference for standards and standardization documents in one area is **24,30 BGN.**

**7.3.** Prices of the service “Subscription on the actuality of standards” for one year

**8.** The price of delivery of foreign and international standards and documents for which BDS has no distribution contracts and agreements is 200 BGN, VAT included, which includes bank charges and shipping costs. In case of need to pay customs duties for the delivery of standards, the costs for that are at the expense of the client.

**9.** The price of the service “Online reading of standards” is as follows:

**9.1.** The price of reading a standard with a selling price<sup>1</sup> of up to 70 BGN incl., is 9,60 BGN.

**9.2.** The price of reading a standard with a selling price of 70.01 BGN and over, is 15% of the selling price of the standard.

**9.3.** The above prices apply for reading by one customer<sup>2</sup> of up to 20 standards in one year. In case the client exceeds 20 standards for reading per year, the price for reading standards becomes 50% of the selling price of the standard, but not less than 9,60 BGN.

**9.4.** In case a customer buys a standard he/she has read, he/she gets a discount on the purchase of the standard to the amount of the price paid for reading the respective standard. The purchased standard is not included in the limit of 20 standards per year.

**10.** For the performance of expert services, including analysis, references, consultation and all other services provided by BDS, the price is subject to negotiation.

**11.** The postal and shipping costs are paid by the customer.

**12.** The payment can be made by bank payment order, electronic payment system e-Pay, bank card through the system Borica, at Easypay cash desks, ATM payment or by bank card at Bulgarian Institute for Standardization cash desk.

**13.** For other BDS editions not covered by this price list, the prices are determined on the basis of calculation.
